

FOR THE
CONSTRUCTION OF TWO (2) STOREY MSWD BUILDING
@ POBLACION, CABATUAN, ILOILO**

THIS AGREEMENT, made this 27th day of **April, 2021**, between **MUNICIPALITY OF CABATUAN, ILOILO** represented by **RONILO O. CASPE**, Municipal Mayor with office address at Cabatuan, Iloilo hereinafter called the "Entity" and **AUDRIC CONSTRUCTION SUPPLY** represented by **ROGINIE J. VILLAR**, Owner with office address at **National Highway, Banga, Aklan** hereinafter called the "Contractor".

WHEREAS, the PROCURING ENTITY is desirous that the CONTRACTOR execute the **CONSTRUCTION OF TWO (2) STOREY MSWD BUILDING @ POBLACION, CABATUAN, ILOILO** hereinafter called "the Works" and the Procuring Entity has accepted the Bid for **THREE MILLION FOUR HUNDRED FORTY TWO THOUSAND SEVEN HUNDRED FORTY SIX PESOS & 03/100 (P3,442,746.03)** by the Contractor for the execution and completion of such Works, within **One Hundred Forty (140) Calendar Days**, and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, works and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:

 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instruction to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulleting, if any;
 - (h) Bid Form, including all the documents/statements contained in the Bidder's Bidding Envelopes, as annexes, and all other documents submitted
 - (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Net Financial Contracting Capacity (NFCC)
 - (l) Notice of Award of Contract and the Bidder's Conforme thereto;
 - (m) Contractor's All Risk Insurance (CARI)
 - (n) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Procuring Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Procuring Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.


