INVITATION TO BID

PR No. 2021-01-0103: Procurement of Solid Waste Decomposing Equipment and Mobile Feeding Conveyor for official use of LGU-Cabatuan, Iloilo

1. The **Local Government Unit of Cabatuan, Iloilo**, through the **Supplemental Budget No. 2, CY 2021** intends to apply the sum of **Nine Million Pesos (Php 9,000,000.00)** being the Approved Budget for the Contract (ABC) to payment under the contract for the **Supply, Delivery, Installation, Testing and Commissioning of One (1) Lot Unit Solid Waste Decomposing Equipment and Mobile Feeding Conveyor**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of Cabatuan, Iloilo** now invites bids for the abovementioned procurement. Delivery of Goods is required within **60 calendar days upon receipt of Notice to Proceed**. Bidders should have completed, **within five (5) years from the date of submission and receipt of bids, a contract similar to the Project**. The description of an eligible bidder is contained in the Bidding documents, particularly, in Section II, Instruction to Bidders.
3. Bidding shall be governed and conducted through open competitive bidding procedures as specified in the Revised Implementing Rules and Regulations of Republic Act No.9184, and such other requirements as indicated in the Bidding Documents.
4. A complete set of Bidding Documents may be inspected and acquired by interested Bidders from the BAC Secretariat in the address below, starting on **May 25, 2021** (*during office hour*), from **9:00 A.M. to 5:00 P.M.** and upon payment of a non-refundable participation fee for the Bidding Documents in the amount of **Ten Thousand Pesos (P10,000.00)**. However, only Bidders who have paid the non-refundable participation fee not later than the deadline for submission of bids on **June 25, 2021, 9:30 A.M** shall qualify to bid. **Opening of bids shall immediately follow at the Conference Room, 2nd Floor, Municipal Bldg, Cabatuan, Iloilo.**
5. The **Local Government Unit of Cabatuan, Iloilo** shall hold the Pre-Bid Conference on **June 11, 2021, 9:30 A.M** at the **Conference Room, 2nd Floor, Municipal Bldg, Cabatuan, Iloilo**, which shall be open to all interested parties with written authorization letter from their principals.

6. Bids must be submitted in the address below accompanied by a bid security in any of the acceptable forms and in the amount stated in the Bidding Documents. The deadline of submission of bids is on **June 25, 2021, 9:30 A.M.** Bid opening shall be held in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

The **Local Government Unit of Cabatuan, Iloilo** reserves the right to accept or reject any bid, including that of the single eligible bidder, waive any minor deviation in the documents submitted which will not materially affect the substance of the bid and to annul the bidding process at any time prior to contract award, without incurring any liability to the affected bidder or bidders.
