A complete set of Bidding Documents may be inspected and acquired by interested Bidders from the BAC Secretariat in the address below, starting on **May 29, 2021 (during office hour)**, from **9:00 A.M. to 5:00 P.M.** and upon payment of a non-refundable participation fee for the Bidding Documents in the amount of **Two Hundred Pesos (P200.00) for each contract.** However, only Bidders who have paid the non-refundable participation fee not later than the deadline for submission of bids on **June 18, 2021, 9:30 A.M** shall qualify to bid. **Opening of bids shall immediately follow at the Conference Room, 2nd Floor, Municipal Bldg, Cabatuan, Iloilo.**

Bids must be submitted in the address below accompanied by a bid security in any of the acceptable forms and in the amount stated in the Bidding Documents. The deadline of submission of bids is on **June 18, 2021, 9:30 A.M.** Bid opening shall be held in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

If the opening of bids will fall on holidays, the schedule of the opening of bids will be on the next working day.

The **Local Government Unit of Cabatuan, Iloilo** reserves the right to accept or reject any bid, including that of the single eligible bidder, waive any minor deviation in the documents submitted which will not materially affect the substance of the bid and to annul the bidding process at any time prior to contract award, without incurring any liability to the affected bidder or bidders.


