## INVITATION TO BID

### Procurement of Oil and Lubricants for the use of LGU Vehicles and Heavy Equipment

1. The **Local Government Unit of Cabatuan, Iloilo**, through the **MO-OMOE** intends to apply the sum of **One Hundred Three Thousand Pesos (₱103,000.00)** being the ABC to payments under the contract for **Procurement of Oil and Lubricants for the use of LGU Vehicles and Equipment** with **PR No. 2021-07-0637**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Local Government Unit of Cabatuan, Iloilo** now invites bids for the above Procurement Project. Delivery of the Goods is **Fifteen (15) calendar days upon receipt of approved Notice to Proceed (NTP)**. Bidders should have completed, within **two (2) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Prospective Bidders may obtain further information from LGU-Cabatuan, Iloilo Bids and Awards Committee Secretariat and inspect the Bidding Documents at the address given below.
5. A complete set of Bidding Documents may be inspected and acquired by interested Bidders from the BAC Secretariat in the address below, starting on **July 24, 2021** (*during office hour*), from **9:00 A.M. to 5:00 P.M.** and upon payment of a non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount of **Two Hundred Pesos (P200.00)**.
6. Bids must be duly received by the BAC Secretariat through manual submission at the **Conference Room, 2nd Floor, Municipal Bldg, Cabatuan, Iloilo**, on or before **August 13, 2021, 9:30 A.M.** Late bids shall not be accepted.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
9. Bid opening shall be on **August 13, 2021, 9:30 A.M** at the **Conference Room, 2nd Floor, Municipal Bldg, Cabatuan, Iloilo**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. **If the opening of bids will fall on non-working day, the schedule of the opening of bids will be rescheduled on the next working day.**
11. The **Local Government Unit of Cabatuan, Iloilo** reserves the right to accept or reject any bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 Revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
