

THIS AGREEMENT made the 2 ^{NOV} day of November 2021 between **LOCAL GOVERNMENT UNIT OF CABATUAN, ILOILO** of Rizal St., Cabatuan, Iloilo (hereinafter called "the Entity") of the one part and **ALLWHEEL AUTOMOTIVE INC.** of Mac Arthur Drive, Brgy. Tabuc Suba, Jaro, Iloilo City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Supply and Delivery of One (1) Brand New JMC Patient Transport Vehicle for the LGU-Cabatuan, Iloilo** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Million Eight Hundred Ninety Nine Thousand Pesos (₱1,899,000.00)**.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:
