

- Progress Billing on contractor's discretion w/ 10% Retention on every billing.
- All documents stated in the Class A Envelope must be valid during opening of Bid.
- The bidders were reminded to familiarize themselves with the provision of 2016 Revised IRR (Implementing Rules and Regulations) of R.A. 9184 (the Government Procurement Reform Act).
- The Checklist of Requirements is already included in the Bid Documents.
- Arrange and label the documents based on the checklist.
