- Supplemental Bid Bulletin must be included in the Bid Submission;
- Single Largest Completed Contract (SLCC) is equivalent to at least 50% of the ABC
- Initial release of 15% as a Mobilization Fee, upon compliance of all pre-release requirements and if they already put up project billboards.
- Subsequent releases shall be via progress billing based on project completion duly supported by LGU's accomplishment report and as built plan approved by the LCE.
- 10% Retention on every Billing.

- Final release of 10% of the contract amount is subject to submission of Certificate of Acceptance by the LGU signifying their acceptance of the fully completed project showing 100% project completion.
- Construction Method shall be prepared by the winning bidder upon signing of Contract.
- Extra Works/Variation Order not exceed 10% of the Contract Price .
