Non-inclusion of the ongoing project, **Construction of Tiring Health Facility at Brgy. Tiring, Cabatuan, Iloilo** in the Statement of All Ongoing Projects result to **misrepresentation of information and ground of post disqualification**.

RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) TO DENY THE MOTION FOR RECONSIDERATION OF VEONG CONSTRUCTION & SUPPLY FOR THE CONTRACT: P.R. NO. 2025-03-0280, CONCRETING OF BARANGAY ROAD OF BRGY. BALABAG, CABATUAN, ILOILO

WHEREAS, presented for consideration of the BAC is the Request for Reconsideration of the Notice of Post-disqualification dated June 13, 2025 for the project – **Concreting of Barangay Road of Brgy. Balabag, Cabatuan, Iloilo**;

WHEREAS, in a letter, the bidder submitted a request for reconsideration citing as follows:

- a. **Sec. 34.3.b.ii item a: of the IRR of R.A. 9184, Negative slippage of at least fifteen percent (15%) in any one project or a negative slippage of at least ten (10) percent in each of two (2) or more contract is a ground of post-disqualification. However, upon checking the project, Improvement of Manguna Check Dam, it only had a negative of 9.73%, which not a subject for post-disqualification pursuant to Sec. 34.3.b.ii item a: of the IRR of R.A. 9184**
- b. Exclusion of the project Construction of Tiring Health Facility at Brgy. Tiring, Cabatuan, Iloilo in its Statement of all-ongoing projects in the government and private contract in its Bidding documents submitted on May 2, 2025 for the contract, CONCRETING OF BARANGAY ROAD AT BRGY. BALABAG, CABATUAN, ILOILO for the reason that it was suspended by Barangay Tiring due to the Relocation of Ileco Post.

WHEREAS, Section 23.1 (a) (iii) of the IRR of RA 9184 requires bidders to submit, as part of their technical documents, a statement of all ongoing government and private contracts, including contracts awarded but not yet started, if any, whether similar or not similar in nature and complexity to the contract to be bid, as provided in the Bidding Documents (hereinafter referred to as "Statement"). The Statement shall include all information required in the Bidding Documents.

WHEREAS, during the Pre-Bid Conference, the BAC emphasized to include all on-going contracts in the Bidding Documents;

WHEREAS, non-inclusion of the ongoing project, **Construction of Tiring Health Facility at Brgy. Tiring, Cabatuan, Iloilo** in the Statement of All Ongoing Projects result to **misrepresentation of information and ground of post disqualification**;

NOW, THEREFORE, for and in view of all the foregoing, WE, the members of the BAC of the Municipality of Cabatuan, Iloilo, by virtue of the powers vested on US by law, hereby


